## ORDER

- (2) The Appellant has filed first Appeal No. ICSOI/A/E/23/00018 on 10.03.2023 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. - (5) The reply of the Respondent against the instant appeal is as under: -

"It is submitted that we have provided the requisite information as sought by the Applicant (Appellant hereinafter) in his RTI Application ICSOI/R/E/23/01034 dated 25.02.2023, at the email id of the Appellant registered with the Institute of Company Secretaries of India vide email dated 09.03.2023 and once again on 24.03.2023 in which a web-link, Username and Password have been provided to the Appellant to access the information sought.
