ORDER

- (1) The Appellant has filed first Appeal- No. ICSOI/A/E/23/00183 on 03.04.2023 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. No. ICSOI/R/E/23/06312 dated 25.03.2023 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- (2) The Appellant vide his application dated 03.03.2023 has requested to provide the certified copy of exam held in December, 2022 of the subjects: Jurisprudence, Interpretation and General Laws(JIGL) - 421 Company Law (Cl) - 422 Setting Up of Business Entities and Closure (SBEC) - 423 Tax Laws(TL) - 424 Corporate and Management Accounting(CMA) - 425 Securities Laws and Capital Markets (SLCM)- 426 Economic, Business and Commercial Laws (EBCL) -427 Financial And Strategic Management (FSM) – 428.
- (3) The Appellant has informed in the instant appeals that “No Response within the Time Limit”.
- (4) The reply of the Respondent against the instant appeal is as under: -

It is submitted that we have provided the requisite information as sought by the Applicant (Appellant hereinafter) in his RTI Application ICSOI/R/E/23/06312 dated 03.03.2023, at the email id of the Appellant registered with the Institute of Company Secretaries of India vide email dated 25.03.2023 and once again on 25.04.2023 in which a web-link, Username and Password have been provided to the Appellant to access the information sought.

Further, the date of accessing the scanned copies has also been extended till 30.04.2023.

The contents as above made in the RTI reply stands as it is and are candid”.

(5) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.

(6) This Office concurs with the submission of the Respondent. Respondent has provided the response to Appellant vide email dated 25.03.2023 and again on 25.04.2023. Further, date extended till 30.04.2023 to access the scanned copies/Information sought. Appellant is requested to check his email id.
