ORDER

- (a) The Appellant has filed first Appeal- No. ICSOI/A/E/23/00185 on 03.04.2023 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. No. ICSOI/R/E/23/07770 dated 03.04.2023 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- (b) The Appellant vide her application dated 09.03.2023 has requested to provide answer sheets for CS Executive examination, Session: December 2022 for subjective papers
- (c) The Appellant has informed in the instant appeal that "Provided Incomplete, Misleading of False Information".
- (d) The reply of the Respondent against the instant appeal is as under: -

"1. It is submitted that requisite information as sought by the Applicant (Appellant hereinafter) in her RTI Application ICSOI/R/E/23/07770 dated 09.03.2023 was ambiguous and incomplete as the same was not containing required credentials i.e. Roll Number/Registration number/ copy of admit card and was disposed of accordingly and informed to the Appellant vide letter dated 03.04.2023.

2. It is further submitted that the Appellant has now provided the requisite credentials in this instant Appeal and thus, the CPIO is of the view that the information sought can be provided and hence the information sought has been provided to the Candidate concerned at her registered email-id vide email dated 28.04.2023 in which a web-link, Username and Password have been provided to the Appellant to access the information sought.

The contents as above made in the RTI reply stands as it is and are candid”.

- (e) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
- (f) This Office concurs with the submission of the Respondent. Respondent has provided the response to Appellant vide email dated 28.04.2023 to access the scanned copies/ information sought. Appellant is requested to check her email id.

The appeal is accordingly disposed of.
