**ORDER**

- (1) The Appellant has filed first Appeal- No. ICSOI/A/E/23/00219 on 09.04.2023 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. No. ICSOI/R/E/23/09038 dated 05.04.2023 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- (2) The Appellant vide her application dated 16.03.2023 has requested to provide the certified copies of CS Executive examination, Session: December 2022 for the subjects: 01 JIGL, 02 COMPANY LAW, 03 SBEC, 04 TAX
- (3) The Appellant has informed in the instant appeal that "Details not Provided".
- (4) The reply of the Respondent against the instant appeal is as under: -

"It is submitted that we have provided the requisite information as sought by the Applicant (Appellant hereinafter) in her RTI Application ICSOI/R/E/23/09038 dated 16.03.2023, at the email id of the Appellant registered with the Institute of Company Secretaries of India vide email dated 05.04.2023 and once again on 01.05.2023 in which a web-link, Username and Password have been provided to the Appellant to access the information sought.

Further, the date of accessing the scanned copies has also been extended till 10.05.2023.

The contents as above made in the RTI reply stands as it is and are candid".

appeal and the records made available and finds that the matter can be decided based on the material available on record.

- (6) This Office concurs with the submission of the Respondent. Appellant is requested to check her email id.
