ORDER

- (1) The Appellant has filed first Appeal- No. ICSOI/A/E/23/00227 on 11.04.2023 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. No. ICSOI/R/E/23/09045 dated 07.04.2023 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.

It is submitted that we have provided the requisite information as sought by the Applicant (Appellant hereinafter) in her RTI Application ICSOI/R/E/23/09045 dated 17.03.2023, at the email id of the Appellant registered with the Institute of Company Secretaries of India vide email dated 07.04.2023 and once again on 01.05.2023 in which a web-link, Username and Password have been provided to the Appellant to access the information sought.

Further, the date of accessing the scanned copies has also been extended till 10.05.2023.
