ORDER

- (1) The Appellant has filed first Appeal- No. ICSOI/A/E/23/00229 on 12.04.2023 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. No. ICSOI/R/E/23/07926 dated 03.04.2023 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- (2) The Appellant vide his application dated 10.03.2023 has requested to provide the certified copies of answer sheet of CS examination held in December, 2022 of the subjects: Jig1 421 Cl 422 Sbec 423 Slcm :426 Ebcl 427 Ebcl
- (3) The Appellant has informed in the instant appeals that "No Response Within the Time Limit".
- (4) The reply of the Respondent against the instant appeal is as under: -

It is submitted that we have provided the requisite information as sought by the Applicant (Appellant hereinafter) in his RTI Application ICSOI/R/E/23/07926 dated 09.03.2023, at the email id of the Appellant registered with the Institute of Company Secretaries of India vide email dated 03.04.2023 and once again on 01.05.2023 in which a web-link, Username and Password have been provided to the Appellant to access the information sought.

Further, the date of accessing the scanned copies has also been extended till 10.05.2023.
