ORDER

- (1) The Appellant has filed first Appeal- No. ICSOI/A/E/23/00261 on 19.04.2023 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. No. ICSOI/R/E/23/09746 dated 13.04.2023 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- (2) The Appellant vide his application dated 19.03.2023 has requested to provide the certified copies of answer sheet of CS Executive Program examination held in December, 2022 of the subjects: 1. 421 Jurisprudence, Interpretation and General Laws, 2. 422 Company Law, 03. 423 Setting up of Business Entities and Closure, 4. 424 Tax Laws
- (3) The Appellant has informed in the instant appeals that "Details not provided".
- (4) The reply of the Respondent against the instant appeal is as under: -

It is submitted that we have provided the requisite information as sought by the Applicant (Appellant hereinafter) in his RTI Application ICSOI/R/E/23/09746 dated 19.03.2023, at the email id of the Appellant registered with the Institute of Company Secretaries of India vide email dated 13.04.2023 and once again on 03.05.2023 in which a web-link, Username and Password have been provided to the Appellant to access the information sought.

Further, the Respondent is directed to extend the date to 20.05.2023 to access the scanned copies/information sought.

The appeal is accordingly disposed of.
