**ORDER**

- (1) The Appellant has filed first Appeal- No. ICSOI/A/E/23/00026 on 13.03.2023 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. No. ICSOI/R/E/23/00585 dated 09.03.2023 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- (2) The Appellant vide his application dated 25.02.2023 has requested "to provide certified copies of answer sheet for CS Professional Programme Session: December 2022 Examination, Subjects: 431 : GOVERNANCE, RISK MANAGEMENT, COMPLIANCES AND ETHICS 432 : ADVANCED TAX LAWS 433 : DRAFTING, PLEADING AND APPEARANCES 434 : SECRETARIAL AUDIT, COMPLIANCE MANAGEMENT AND DUE DILIGENCE 435 : CORPORATE RESTRUCTURING, INSOLVENCY, LIQUIDATION AND WINDING UP 436 : RESOLUTION OF CORPORATE DISPUTES, NON-COMPLIANCES AND REMEDIES 437 : CORPORATE FUNDING AND LISTINGS IN STOCK EXCHANGES 438 : MULTIDISCIPLINARY CASE STUDIES (MCS) 448 : INSOLVENCY - LAW AND PRACTICE (INLP).
- (3) The Appellant has informed in the instant appeals that "No Response Within the Time Limit".

(4) The reply of the Respondent against the instant appeal is as under: -

“It is submitted that we have provided the requisite information as sought by the Applicant (Appellant hereinafter) in her RTI Application ICSOI/R/E/23/00585 dated 25.02.2023, at the email id of the Appellant registered with the Institute of Company Secretaries of India vide email dated 07.03.2023 and once again on 24.03.2023 in which a web-link, Username and Password have been provided to the Appellant to access the information sought.

The contents as above made in the RTI reply stands as it is and are candid”.

- (5) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
- (6) This Office concurs with the submission of the Respondent. Response provided by CPIO EXAM to the Appellant to access the information sought vide email dated 07.03.2023 and once again on 24.03.2023 at registered email ID.

The appeal is accordingly disposed of.
