(6) This Office concurs with the submission of the Respondent. Respondent has provided the response to Appellant vide email dated 17.04.2023 and again on 03.05.2023. Further, date extended till 10.05.2023 to access the scanned copies/Information sought. Appellant is requested to check his email id. Further, the Respondent is directed to extend the date to 20.05.2023 to access the scanned copies/information sought.

The appeal is accordingly disposed of.
