ORDER

- (1) The Appellant has filed first Appeal- No. ICSOI/A/E/23/00270 on 20.04.2023 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. No. ICSOI/R/E/23/10516 dated 17.04.2023 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- (2) The Appellant vide his application dated 21.03.2023 has requested to provide the certified copies of CS Executive Program examination held in December, 2022 of the subjects: 1. JIGL (Code-421), 2. Company Law (Code-422), 03. SBEC (Code-423), 4. Tax Laws (Code-424)
- (3) The Appellant has informed in the instant appeals that "Details not provided".
- (4) The reply of the Respondent against the instant appeal is as under: -

It is submitted that we have provided the requisite information as sought by the Applicant (Appellant hereinafter) in his RTI Application ICSOI/R/E/23/10516 dated 21.03.2023, at the email id of the Appellant registered with the Institute of Company Secretaries of India vide email dated 17.04.2023 and once again on 03.05.2023 in which a web-link, Username and Password have been provided to the Appellant to access the information sought.

Further, the date of accessing the scanned copies has also been extended till 10.05.2023.

Further, the Respondent is directed to extend the date to 20.05.2023 to access the scanned copies/information sought.
