The contents as above made in the RTI reply stands as it is and are candid".

- (6) This Office concurs with the submission of the Respondent. Response provided by CPIO EXAM to the Appellant to access the information sought vide email dated 10.03.2023 and once again on 29.03.2023 at registered email ID.
