ORDER

- (1) The Appellant has filed first Appeal- No. ICSOI/A/E/23/00274 on 21.04.2023 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. No. ICSOI/R/E/23/04460 dated 20.03.2023 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- (2) The Appellant vide his application dated 28.02.2023 has requested to provide the certified copies of answer sheets of CS Executive Program examination held in December, 2022 for the subjects: 1. 421-JIGL, 2. 422-Company Law, 3. 423-SBEC, 4. 424-Tax Law
- (3) The Appellant has informed in the instant appeals that "Details not provided".
- (4) The reply of the Respondent against the instant appeal is as under: -

It is submitted that we have provided the requisite information as sought by the Applicant (Appellant hereinafter) in his RTI Application ICSOI/R/E/23/04460 dated 28.02.2023, at the email id of the Appellant registered with the Institute of Company Secretaries of India vide email dated 20.03.2023 and once again on 03.05.2023 in which a web-link, Username and Password have been provided to the Appellant to access the information sought.

Further, the date of accessing the scanned copies has also been extended till 10.05.2023.

Further, the Respondent is directed to extend the date to 20.05.2023 to access the scanned copies/information sought.
