ORDER

- (1) The Appellant has filed first Appeal-No. ICSOI/A/E/23/00279 on 25.04.2023 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. No. ICSOI/R/E/23/02191 dated 18.03.2023 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.

Appellant is requested to check her email id. Further, the Respondent is directed to extend the date to 20.05.2023 to access the scanned copies/information sought.

The appeal is accordingly disposed of.
