## ORDER

- (3) The Appellant has informed in the instant appeal that "Details not Provided".
- (4) The reply of the Respondent against the instant appeal is as under: -
  - "It is submitted that we have provided the requisite information as sought by the Applicant (Appellant hereinafter) in her RTI Application ICSOI/R/E/23/11721 dated 06.04.2023, at the email id of the Appellant registered with the Institute of Company Secretaries of India vide email dated 28.04.2023 and once again on 12.05.2023 in which a web-link, Username and Password have been provided to the Appellant to access the information sought.

Further, the date of accessing the scanned copies has also been extended till 20.05.2023.

The contents as above made in the RTI reply stands as it is and are candid".
