"It is submitted that the information sought was the Answer Books of the Applicant (Appellant hereinabove) in respect of his appearance in CS Examination, December 2022 session, and that the Answer Books of the CS Examination, December 2022 have been disposed of in accordance with the Record Retention Schedule of Directorate of Examinations, ICSI and hence, the same cannot be provided.

The contents as above made in the RTI reply stands as it is and are candid".

- (5) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
- (6) This Office concurs with the submission of the Respondent. Respondent has informed to the Appellant on 16.05.2023 in respect of his appeal that the answer books of the CS Examination, December 2022 has been disposed of in accordance with the record retention schedule of The Directorate of Examination, in ICSI. Therefore, the same cannot provided.
