- (1) The Appellant has filed first Appeal- No. ICSOI/A/E/23/00303 on 20.05.2023 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. No. RTI 2005/5527/(23) dated 16.05.2023 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- (2) The Appellant vide his application dated 25.04.2023 has requested to provide the information about CS Pankaj Gupta Company Secretary Dhanvantri Jeevan Rekha Limited Meerut since 01.12.2000 missing. The information sought is exempted under Section 8(1)(j) of the RTI Act, 2005

Therefore, the appeal deserves to be dismissed.

- (5) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.

order.
