The contents as above made in the RTI reply stands as it is and are candid.

- (5) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
- (6) This Office concurs with the submission of the Respondent. It has been noticed that the Answer Books of the CS Examination, December 2022 have been disposed of in accordance with the Record Retention Schedule of the Directorate of Examinations, ICSI. Hence, the same cannot be provided.

The Appeal is accordingly disposed of.
