**ORDER**

- (1) The Appellant has filed first appeal No. ICSOI/A/E/23/00313 on 25.06.2023 under Section 19(1) of the Right to Information Act, 2005 in connection with response Ref. No. RTI 2005/5534/(23) dated 13.06.2023 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute.
- (2) The Appellant vide his RTI application dated 19.05.2023 has requested to provide the various information regarding BCOM in Corporate Affairs and Administration Couse provided by IGNOU.
- (3) The Appellant has informed in the instant appeal that "Details not provided" & requested to "please send me the pdf of MOU signed between ICSI and IGNOU dated 12th July 2022. Because I am unable to get that elsewhere".
- (4) The reply of the Respondent against the instant appeal is as under: -

"CPIO has provided its reply dated 13.06.2023 in response to the RTI Application dated 19.05.2023. In the RTI Appeal dated 25.06.2023, the appellant has raised 1 new query and accordingly the same cannot be added to the queries of the RTI Application dated 19.05.2023 at the 1st appeal stage.

Therefore, we reiterate our reply dated 13.06.2023 and the appeal deserves to be dismissed".

- (5) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
- (6) This Office concurs with the submission of the Respondent as no other information was sought by the appellant in the RTI Application.

The appeal is accordingly disposed of.
