ORDER

- (1) The Appellant has filed first appeal No. ICSOI/A/E/23/00316 on 07.07.2023 under Section 19(1) of the Right to Information Act, 2005 in connection with response Ref. No. RTI 2005/5555/(23) dated 07.07.2023 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute.
- (2) The Appellant vide his RTI application No. ICSOI/R/E/23/12257 dated 15.06.2023 has requested to provide the details for the post of Office Assistant, marks scored by all the candidates of written test which is held on 29.10.2022 & question paper and answer sheet of the candidate name Surya Prakash Mishra (Roll No 2022/OA/023) and answer key of the question paper of the office assistant written test.
- (3) The Appellant has informed in the instant appeal that "Provided Incomplete, Misleading or False Information".
- (4) The reply of the Respondent against the instant appeal is as under: -

"CPIO has provided its reply dated 07.07.2023 in response to the RTI Application dated 15.06.2023, in which the pdf file of the advertisement enclosed by the RTI applicant was not opening. Since questions pertain to ICSI, reply accordingly was given. In the RTI Appeal, the applicant has annexed a new document regarding career opportunities of ICSI-IIP and accordingly the same cannot be added to the queries of the RTI Application dated 15.06.2023 at the 1st appeal stage.

The applicant is at liberty to make a separate RTI Application for ICSI-IIP advertisement as attached in this instant RTI Appeal. However, it is learnt from ICSI-IIP that the advertisement dated 06.07.2022 inviting applications for the post of Office Assistant has been withdrawn. The same has been posted in the 'Announcements' section under 'What's New' on the official website of ICSI-IIP at <https://icsiip.in/>. Further, the marks of all candidates are exempted under Section 8(1)(j) of the RTI Act,

Accordingly, the appeal is devoid of any merit and should be rejected.”

- (5) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
- (6) This Office concurs with the submission of the Respondent that marks of candidates are exempted under 8(1)(j) of the RTI Act.

The appeal is accordingly disposed of.
