ORDER

- (1) The Appellant has filed first Appeal- No. ICSOI/A/E/23/00334 on 12.09.2023 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. No. ICSOI/R/E/23/14012 dated 12.09.2023 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- (2) The Appellant vide his application dated 25.08.2023 has requested to provide the photocopy of answer book for CS Professional Examination held in June 2023 for the subjects: 431 GOVERNANCE, RISK MANAGEMENT, COMPLIANCES AND ETHICS (GRMCE) , 432 : ADVANCED TAX LAWS (ATL), 433: DRAFTING, PLEADINGS AND APPEARANCES (DPA), 434: SECRETARIAL AUDIT, COMPLIANCE MANAGEMENT AND DUE DILIGENCE (SACMDD), 435: CORPORATE RESTRUCTURING, INSOLVENCY, LIQUIDATION AND WINDING-UP (CRILW), 436: RESOLUTION OF CORPORATE DISPUTES, NONCOMPLIANCES AND REMEDIES (RCDNR), 437: CORPORATE FUNDING AND LISTINGS IN STOCK EXCHANGES (CFLSE), 438: MULTIDISCIPLINARY CASE STUDIES, 448: INSOLVENCY - LAW AND PRACTICE (INLP).
- (3) The Appellant has informed in the instant appeal that "Details not provided".
- (4) The reply of the Respondent against the instant appeal is as under: -

"It is submitted that the requisite information as sought by the Applicant (Appellant hereinafter) in his RTI Application ICSOI/R/E/23/14012 dated 25.08.2023, is in public domain and freely available without any cost at link <https://cc.icsi.edu>.

Further, the Appellant was informed about the said link and the procedure to fetch the sought information vide letter dated 12.09.2023. An announcement in this regard has also been published on the website of the Institute.

Furthermore, it is to inform that Appellant has already accessed the required information through the above mentioned portal.

The contents as above made in the RTI reply stands as it is and are candid”.

(5) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.

The requisite information as sought by the Appellant was freely available in public domain without any cost at link <https://cc.icsi.edu> as intimated by CPIO EXAM to the appellant vide communication dated 12.09.2023.

Further, CPIO EXAM has substantiated that Appellant has already accessed the required information through the above-mentioned portal.

The appeal is accordingly disposed of.
