ORDER

- (1) The Appellant has filed first Appeal- No. ICSOI/A/E/23/00337 on 13.09.2023 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. "It is submitted that the requisite information as sought by the Applicant (Appellant hereinafter) in her RTI Application ICSOI/R/E/23/13379 dated 25.08.2023, is in public domain and freely available without any cost at link https://cc.icsi.edu.

Further, the Appellant was informed about the said link and the procedure to fetch the sought information vide letter dated 11.09.2023. An announcement in this regard has also been published on the website of the Institute.

Furthermore, it is to inform that Appellant has already accessed the required information through the above mentioned portal (screenshot attached).

The contents as above made in the RTI reply stands as it is and are candid".

(5) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.

The requisite information as sought by the Appellant was freely available in public domain without any cost at link https://cc.icsi.edu as intimated by CPIO EXAM to the appellant vide communication dated 11.09.2023.

Further, CPIO EXAM has substantiated that Appellant has already accessed the required information through the above-mentioned portal.

The appeal is accordingly disposed of.
