ORDER

 - 3. Furthermore, the Appellant acknowledged the receipt of the same vide email dated 10.04.2023.

The contents as above made in the RTI reply stands as it is and are candid".

- (e) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
- (f) This Office concurs with the submission of the Respondent. It has been noticed that Appellant acknowledged the receipt of the answer sheets vide email dated 10.04.2023.

The appeal is accordingly disposed of.
