ORDER

- (1) The Appellant has filed first Appeal- No. ICSOI/A/E/23/00042 on 15.03.2023 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. - (3) The Appellant has informed in the instant appeals that "Provided Incomplete, Misleading or False Information".
- (4) The reply of the Respondent against the instant appeal is as under: -

"It is submitted that we have provided the requisite information as sought by the Applicant (Appellant hereinafter) in her RTI Application ICSOI/R/E/23/02833 dated 27.02.2023, at the email id of the Appellant registered with the Institute of Company Secretaries of India vide email dated 15.03.2023 and once again on 10.04.2023 in which a web-link, Username and Password have been provided to the Appellant to access the information sought.

Further, the date of accessing the scanned copies has also been extended till 01.05.2023.

The contents as above made in the RTI reply stands as it is and are candid".

- (5) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
- (6) This Office concurs with the submission of the Respondent. Response provided by CPIO EXAM to the Appellant to access the information sought vide email dated 15.03.2023 and once again on 10.04.2023 & also date extended till 01.05.2023 for accessing the scanned copies. Appellant is requested to check her registered email ID.

The appeal is accordingly disposed of.
