Response provided by CPIO EXAM to the Appellant to access the information sought vide email dated 14.03.2023 and once again on 05.04.2023 & also date extended till 15.04.2023 for accessing the scanned copies. Appellant is requested to check his registered email ID.

The appeal is accordingly disposed of.
