ORDER

- (1) The Appellant has filed first Appeal- No. ICSOI/A/E/23/00073 on 19.03.2023 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. No. ICSOI/R/E/23/02113 dated 14.03.2023 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- (2) The Appellant vide her application dated 26.02.2023 has requested to provide certified photocopy of answer sheet of CS Executive Programme, Session: December 2022 Examination Subjects: PAPER 1: JURISPRUDENCE, INTERPRETATION & GENERAL LAWS, PAPER 2: COMPANY LAW, PAPER 3: SETTING UP OF BUSINESS ENTITIES AND CLOSURE, PAPER 4 : TAX LAW.
- (3) The Appellant has informed in the instant appeals that "Provided Incomplete, Misleading or False Information."
- (4) The reply of the Respondent against the instant appeal is as under: -

"It is submitted that we have provided the requisite information as sought by the Applicant (Appellant hereinafter) in her RTI Application ICSOI/R/E/23/02113 dated 26.02.2023, at the email id of the Appellant registered with the Institute of Company Secretaries of India vide email dated 14.03.2023 and once again on 07.04.2023 in which a web-link, Username and Password have been provided to the Appellant to access the information sought.

Further, the scanned copy of answerbook of "Tax Law" (Paper sought: 424) was also included in the information provided.

Further, the date of accessing the scanned copies has also been extended

till 20.04.2023.

The contents as above made in the RTI reply stands as it is and are candid”.

- (5) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
- (6) This Office concurs with the submission of the Respondent. Response provided by CPIO EXAM to the Appellant to access the information sought vide email dated 14.03.2023 and once again on 07.04.2023 & also date extended till 20.04.2023 for accessing the scanned copies. Appellant is requested to check her registered email ID.

The appeal is accordingly disposed of.
