ORDER

- (1) The Appellant has filed first Appeal- No. ICSOI/A/E/24/00001 on 08.01.2024 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref No. ICSOI/R/E/23/25643 dated 08.01.2024 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- (2) The Appellant vide his application dated 12.12.2023 has requested to provide the following information:
- 1) How many candidates appeared in the exam 15/10/2023?
 - 2) When was the result declared for the said exam?
 - 3) Who are the members of Examination Committee involved in the process? Please give specific name and designation they hold in ICSI?
 - 4) What was the cut off marks for the said exam? If results are declared?
 - 5) How many candidates are called for interview? What is the ratio in which they are called?
 - 6) Photocopy of written examination sheet of RTI filler/candidate (Mr. Shrey Singh) bearing roll no. 21004?
- (3) The Appellant has informed in the instant appeal that “Refused access to Information requested”.
- (4) The reply of the Respondent against the instant appeal is as under: -

“The applicant in his RTI application date 12.12.2024 seeking 06 information regarding the recruitment of Executive (Law) of Level 8 (Grade pay). The same was replied by the CPIO on 08.01.2024.

In the meantime, the result have been finalized and intimation have been sent to the selected candidates. Therefore, we have no objection for providing reply to Query numbers 1, 2, 4, 5 and 6.

Regarding query no. 3, no such nomenclature "Examination Committee" was constituted".

- (5) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
- (6) For queries mentioned at Sl. No 1,2,4,5 and 6 CPIO-ICSI is advised to provide the Appellant with required information within 7 days from the issue of this Order.

The appeal is accordingly disposed of.
