- 5. Type of Certificate/Report
- 6. Date of Signing of Document
- 7. Document Description
- 8. Status: (UDIN status) "
- (5) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
- (6) CPIO ICSI has provided the required information as stated above. The Appellant may take note of the information so provided by CPIO ICSI.

The appeal is accordingly disposed of.
