ORDER

- (1) The Appellant has filed first Appeal- No. ICSOI/A/E/26/00002 on 19/01/2026 under Section 19(1) of the Right to Information Act, 2005 in connection with Response vide letter dated 06/01/2026 against the Central Public Information Officer (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- (2) The Appellant vide his RTI Application No. ICSOI/R/E/25/03600 dated 10/12/2025 has requested the following information:

"My name is Prashant kumar i appeared in the exam of executive assistant Advertisement No. ADVT.NO.01/2025 and Roll No.1001090095 On the date of 27/09/2025. I want to know that:

1. My Raw marks in the examination of Executive Assistant.
 2. What is the cutoff for unreserved category.
- (3) The Appellant has submitted in his instant appeal regarding the reply provided by the Respondent to the RTI queries as under:

"I am writing to request a rechecking of my answer script as I believe my marks are higher than what has been declared. As per the information provided to me

under RTI, my marks are 55. However, I am confident that my performance in the examination was better and my marks should be above the cutoff. I request you to kindly arrange for a rechecking of my answer script to ensure accuracy and fairness."

(4) The reply of the Respondent against the instant appeal is as under: -

"We reiterate our earlier reply dated 06.01.2026 as the requisite information has already been provided to the RTI applicant (Appellant herein).

Further, it is necessary to mention that after providing the requisite information, RTI Appellant is seeking afresh information in his 1st appeal by requesting rechecking of marks which he had not asked in the RTI application earlier."

Therefore, the contents made in the RTI Reply stands as it is and the appeal deserves to be dismissed."

(5) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.

This office concurs with the submissions of the Respondent in his reply to the instant appeal.

The appeal is accordingly disposed of.
