- (1) The Appellant has filed first Appeal- No. ICSOI/A/E/24/00003 on 17.01.2024 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref No. ICSOI/R/E/23/00215 dated 03.01.2024 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- (2) The Appellant vide his application dated 05.12.2023 has requested to provide the following information:

- (3) The Appellant has informed in the instant appeal that "Provided incomplete, misleading or false information".
- (4) The reply of the Respondent against the instant appeal is as under: -

"Since the RTI application pertains to Directorate of Discipline of the ICSI, therefore, the CPIO has asked for written submission from concerned Directorate for the same. Their submission is mentioned below:

In response of the RTI Application, the desired information was provided by the Directorate of Discipline."

Therefore, the contents made in the RTI reply stands as it is and the appeal deserves to be dismissed".

- (5) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
- (6) CPIO ICSI in his response has stated that the desired information was provided by Directorate of Discipline. In RTI reply also, it was stated by CPIO that the procedure for filing complaint was informed to the Appellant.

The Appellant may take note of the information so provided by CPIO ICSI.

The appeal is accordingly disposed of.
