The requisite information as sought by the Appellant was freely available in public domain without any cost at Link https://cc.icsi.edu as intimated by CPIO EXAM to the appellant vide communication dated 29.02.2024.

Further, CPIO EXAM has substantiated that Appellant has already accessed the required information through the above-mentioned portal.
