ORDER

"It is submitted that the requisite information as sought by the Applicant (Appellant hereinafter) in her RTI Application ICSOI/R/E/24/00926 dated 25.02.2024, was made available in public domain and was freely available without any cost at link https://cc.icsi.edu. An announcement in this regard has also been published on the website of the Institute (copy of Announcement attached).

Further, it is to inform that the Appellant has already accessed the requisite Answer Books from the Answer Book portal on 11.03.2024 (Screen shot attached).

The contents as above made in the RTI reply stands as it is and are candid".

(5) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.

The requisite information as sought by the Appellant was freely available in public domain without any cost at Link https://cc.icsi.edu as intimated by CPIO EXAM to the appellant vide communication dated 01.03.2024.

Further, CPIO EXAM has substantiated that Appellant has already accessed the required information through the above-mentioned portal.
