ORDER

- (1) The Appellant has filed first Appeal- No. ICSOI/A/E/24/00010 on 02.03.2024 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref No. ICSOI/R/E/24/00842 dated 01.03.2024 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- (2) The Appellant vide his application dated 25.02.2024 has requested to provide the certified copies for CS Executive Dec 2023 examination for the subjects:
1)SLCM (paper code -426) 2) EBCL (427) 3)CMA (425) 4)FSM(428) 5) Tax Laws (424).
- (3) The Appellant has informed in the instant appeal that “Refused access to information requested”.
- (4) The reply of the Respondent against the instant appeal is as under: -

“It is submitted that the requisite information as sought by the Applicant (Appellant hereinafter) in his RTI Application ICSOI/R/E/24/00842 dated 25.02.2024, was made available in public domain and was freely available without any cost at link <https://cc.icsi.edu>. An announcement in this regard has also been published on the website of the Institute (copy of Announcement attached).

Further, the relevant information as mentioned above was provided to the Appellant on 01.03.2024 and accordingly the RTI Application was disposed of.

Furthermore, it is to inform that the Appellant has already accessed the requisite Answer Books from the Answer Book portal on 06.03.2024 (Screenshot attached).

The contents as above made in the RTI reply stands as it is and are candid”.

(5) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.

The requisite information as sought by the Appellant was freely available in public domain without any cost at Link <https://cc.icsi.edu> as intimated by CPIO EXAM to the appellant vide communication dated 01.03.2024.

Further, CPIO EXAM has substantiated that Appellant has already accessed the required information through the above-mentioned portal.
