ORDER

- (1) The Appellant has filed first Appeal- No. ICSOI/A/E/24/00012 on 06.03.2024 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref No. ICSOI/R/E/24/00220 dated 06.03.2024 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
 - (2) The Appellant vide his application dated 13.02.2024 has requested to provide answers to following queries:
 - 1. If I cleared any group of Executive or Professional, will i be eligible to give that group(s) again for improvement of my marks? Explain the process of surrendering the result of that passed group.
 - 2. If I appeared in the Examination of Executive Programme in both groups and suppose I cleared both groups too but didnot able to bring All India Rank in that examination. Now if i want to give both groups again for improvement of my marks and for All India Rank so will i be eligible for All India Rank?
 - 3. If I appeared in the Examination of Executive Programme of 1st group and suppose cleared that group Now i want to give examination of both groups (1st group already cleared and want to give 1st group again along with 2nd group) will be eligible for All India Rank?
- (3) The Appellant has informed in the instant appeal that "Provided incomplete, misleading or false information".
- (4) The reply of the Respondent against the instant appeal is as under: -

"It is submitted that the requisite information as sought by the Applicant (Appellant hereinafter) in his RTI Application ICSOI/R/E/24/00220 dated 13.02.2024, was based upon his assumptions and imaginary situations. The queries asked by him are not considered as information under section 2(f) of the RTI Act.

However, all the closest relevant guidelines in connection to the hypothetical questions asked by the Appellant were provided to him vide letter dated 06.03.2024 (copy of letter attached) and no other information is further required to be provided.

The contents as above made in the RTI reply stands as it is and are candid".

(5) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.

This Office concurs with the submission of the Respondent.

The appeal is accordingly disposed of.
