(3) The Appellant has submitted in the instant appeal as follows:

"I have requested the answer sheet for the previously held exam CS EXECUTIVE DEC24 attempt which result was declared on 25th feb 2025 and made a request on 26th feb 2025. I didn't receive any mail or text about the request being available and on 7th march 2025 i got a text message referring the final decision has been arrived. I logged in the RTI portal and the request was deposed before i got access to the information being available. I didn't get my answer sheet. I couldn't appeal before because i was engaged in admission for my upcoming exam."

(4) The reply of the Respondent against the instant appeal is as under: -

"It is submitted that the requisite information as sought by the Applicant (Appellant hereinafter) in her RTI Application ICSOI/R/E/25/00706 dated 26.02.2025, was provided to her vide letter dated 07/03/2025, in which the appellant was informed about weblink and the procedure to fetch the sought information (Copy of letter Enclosed). An announcement in this regard was also published on the website of the institute. The above information was also provided to appellant by mail dated 07/03/2025 (Copy of mail enclosed).

further it is to inform that the information sought was also made available to the appellant in the "ICSI Answer Book Portal" within the stipulated time frame i.e. 17/03/2025 to 10/04/2025 and the appellant has already been accessed the required information through the above-mentioned portal (Copy of screen shot attached).

The contents as above made in the RTI reply stands as it is and are candid.

Therefore, the appeal deserves to be dismissed *in-limine*."

(5) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.

This office concurs with the submissions of the Respondent.

The appeal is accordingly disposed of.
