ORDER

- (1) The Appellant has filed first Appeal- No. ICSOI/A/E/25/00017 on 27.03.2025 under Section 19(1) of the Right to Information Act, 2005 in connection with the Response vide letter dated 07.03.2025 against the Central Public Information Officer (EXAM) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- (2) The Appellant vide his RTI Application No. ICSOI/R/E/25/00673 dated 26.02.2025 has requested the following information:

“Dear Sir/Mam,

This is to request you that i am the student of ICSI for professional programme and attempted for december 2024 but unfortunately cannot clear the same, therefore i request the institute to please provide me the certified copies so that i can look into my mistakes and improve next time. Details are as mentioned below.

- (3) The Appellant has submitted in the instant appeal as follows:

“Dear ICSI,

I have requested for certified copies in pdf form which i have written in my december

attempt 2024. I want the copies complete so that i can check my mistakes and learn from then and attempt in better manner, but the information provided to me is incomplete because in that only Marks calculation is there not the complete written Answer sheet. I request you to please consider the same and provide me the same as soon as possible.”

(4) The reply of the Respondent against the instant appeal is as under: -

“It is submitted that the requisite information as sought by the Applicant (Appellant hereinafter) in his RTI Application ICSOI/R/E/25/00673 dated 26.02.2025 was provided to the Appellant vide letter dated 07/03/2025, in which the Appellant was informed about weblink and the procedure to access the Answer Books through “**ICSI Examination Answer Books Portal**”(Copy of letter enclosed).

Further, it has been observed that the Appellant accessed the scanned copies of Answer Books through the said portal on multiple occasions (copy of Screen shot attached).

Furthermore, the information provided was correct and complete in all respects and no other information is required to be given.

The contents as above made in the RTI reply stands as it is and are candid.

Therefore, the appeal deserves to be dismissed *in-limine*.”

(5) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.

This office concurs with the submissions of the Respondent.

The appeal is accordingly disposed of.
