ORDER

- (1) The Appellant has filed first Appeal- No. ICSOI/A/E/24/00019 on 11.03.2024 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref No. ICSOI/R/E/24/00232 dated 11.03.2024 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- (2) The Appellant vide her application dated 17.02.2024 has requested to provide the following information:
 1. The criteria used to make the final selection for the post.
 2. Qualifications/Marks of the finally selected candidate
 3. Reasons of non-selection of the applicant over the selected candidate, if the same is not cleared from the reply to query no. 1 and 2.
- (3) The Appellant has informed in the instant appeal that “Refused access to Information requested”.
- (4) The reply of the Respondent against the instant appeal is as under: -

“Since the RTI application pertains to the Directorate of Human Resources of the ICSI, therefore, the CPIO has asked for written submission from the concerned Directorate for the same. Their submission is mentioned below:-

It is to inform that after submission of RTI reply, the joining process for the post of Executive (Law) has now been completed. Therefore, the CPIO has no objection if First Appellate Authority deem it fit providing the same to the appellant”.
- (5) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.

(6) CPIO-ICSI is advised to provide the Appellant with required information within 30 days from the issue of this Order.

The appeal is accordingly disposed of.
