ORDER

- (1) The Appellant has filed first Appeal No. ICSOI/A/E/26/00031 on 12/06/2026 under Section 19(1) of the Right to Information Act, 2005 in connection with Response vide letter dated 08/05/2026 against the Central Public Information Officer (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- (2) The Appellant vide his RTI Application No. ICSOI/R/E/26/01345 dated 13/04/2026 has requested the following information:

"For the post ADVT. NO. 02/2026, How many number of applications were received to Joint Director (Infrastructure and Building Maintenance) and Assistant Engineer (Infrastructure, Building Maintenance). kindly provide the caste wise applications for each post."
- (3) The Appellant has submitted in his instant appeal regarding the reply provided by the Respondent to the RTI queries as under:

"Many examinations like ESE, GATE, UPSC AND SSC are giving the asked information Even though The recruitment process for the said posts is under process. Hope the RTI rule is not different for different organizations. Kindly give the number of applications received for joint director and Assistant Engineer."

(4) The reply of the Respondent against the instant appeal is as under: -

"It may be noted that the reply against the RTI application was sent on 08.05.2026 and the 1st appeal dated 12.06.2026 received in the Institute on 12.06.2023, therefore, without going into the merit of the appeal, it is observed that the appellant has preferred this 1st appeal after the prescribed period for preferring an appeal (i.e. within 30 days from receipt of reply of RTI application) under Section 19(1) of the RTI Act, 2005. Request Disposed Off Letter along with reply is attached herewith for ready reference as **Annexure – A.**"

Therefore, the appeal is barred by law of limitation and may kindly be dismissed."

- (5) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
- (6) This office concurs with the submissions of the Respondent in his reply to the instant appeal.
- (7) The appeal is accordingly disposed of.

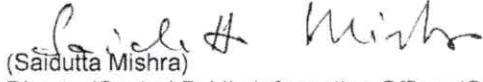
