- (4) The reply of the Respondent against the instant appeal is as under: -

"It is submitted that procedure to obtain the requisite information as sought by the Applicant (Appellant hereinafter) in RTI Application ICSOI/R/E/25/02513 dated 26.08.2025, was provided to her on 01.09.2025 in which the Appellant was informed about weblink and the procedure to fetch the sought information (Copy of letter enclosed).

An announcement in this regard was also published on the website of the Institute <a href="www.icsi.edu">www.icsi.edu</a> - Examination - Result - Announcement (Supply of copy of Answer Book(s) to the students of CS Examination - June, 2025) in which students have been advised to apply for scanned Answer Books at the "ICSI Examination Answer Books Portal" only (Copy of Announcement attached).

However, the Appellant did not apply at the said portal to access her Answer Books.

Further, it is to inform that the copy of evaluated Answer Books of June 2025 shall remain available till the expiry of Retention Period i.e. ordinarily up to 45 days of declarations of results of examination, and thus the student may apply for the aforesaid information within the prescribed time period i.e. upto 09<sup>th</sup> Oct 2025(Copy of Record Retention Schedule attached).

In case, the student wants certified copy of evaluated Answer Book, her application will be treated as per the guidelines for the same. Further, the Answer Book will be available after completion of prescribed procedure. Announcement to this effect and guidelines for providing Certified Copy are also available at the website of the Institute at weblink <a href="https://www.icsi.edu/media/webmodules/2">https://www.icsi.edu/media/webmodules/2</a> Announcement C C and Inspection of Answer Books June %202025.pdf

The contents as above made in the RTI reply stands as it is and are candid.

Therefore, the appeal deserves to be dismissed in-limine."

(5) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.

This office concurs with the submissions of the Respondent.

The appeal is accordingly disposed of.
