## **ORDER**

- (1) The Appellant has filed first Appeal No. ICSOI/A/E/25/00061 on 07.09.2025 under Section 19(1) of the Right to Information Act, 2005 in connection with the Response vide letter dated 03.09.2025 against the Central Public Information Officer (EXAM) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- (2) The Appellant vide RTI Application No. ICSOI/R/E/25/02799 dated 29.08.2025 has requested the following information:

(3) The Appellant has submitted in the instant appeal as follows:

"Respected Sir,

I have already placed the request for viewing answer books on ICSIEXAMINATION ANSWER BOOK PORTAL. Also, another point to be noted was that I had also applied for Verification of Marks on the ICSI portal and it says that the answer books will be available on answer book portal after Verification of marks is completed. Now the technical problem here is that the end date of viewing answer books on Answer book portal is 28/10/2025. And the estimated time displayed for completion of Verification of marks is displayed as minimum 7 to 8 weeks. Which means that by the time Verification of Marks is completed, the last date for viewing Answer books i.e. 28/10/2025 will either be crossed or I will be left only with a slim margin of time. If this occurs, it would mean that I would not be able to access my answer books on the Answer books portal. Hence, I request you to kindly provide me copies of my answer books through the RTI portal.

Your cooperation will be highly obliged.

Thank you"

(4) The reply of the Respondent against the instant appeal is as under: -

"It is submitted that the requisite information as sought by the Applicant (Appellant hereinafter) in his RTI Application ICSOI/R/E/25/02799 dated 29.08.2025, was provided to the Appellant vide letter dated 03.09.2025 in which the Appellant was informed about weblink and the procedure to fetch the information (copy of letter enclosed).

Subsequently, it has been found that the Applicant had already registered at "ICSI Examination Answer Books Portal" on 26.08.2025, and the Answer Books were made available to the Appellant within the specified time frame, which have also been viewed by the Appellant (copy of screenshot attached).

Now, in the instant Appeal, the Appellant requested to provide his Answer Books through "RTI Portal" because he has also applied for "Verification of Marks" and as per procedure Answer Books can be provided only after the verification process is completed.

It is to be submitted that in such cases the time-period of viewing of Answer Books is increased to give sufficient time to the Appellant to view his Answer Books.

In this case copies were made available to the Appellant after completion of Verification process and the same has also been viewed by the Appellant also, on 17.09.2025 at "ICSI Examination Answer Books Portal" (Screen Shot attached).

The contents as above made in the RTI reply stands as it is and are candid.

Therefore, the appeal deserves to be dismissed in-limine."

(5) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.

This office concurs with the submissions of the Respondent.

The appeal is accordingly disposed of.
