ORDER

- (1) The Appellant has filed first Appeal- No. ICSOI/A/E/24/00071 on 10.07.2024 under Section 19(1) of the Right to Information Act, 2005 in connection with Response vide letter dated 03.07.2024 against the Central Public Information Officer (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- (2) The Appellant vide his RTI Application No. ICSOI/R/E/24/08123 dated 12.06.2024 has requested to provide information as per his following queries:
 - a) With reference to ICSI career opportunities advertisement dated 31st January 2024 for the post of Information Security Officer and IT Security Manager. Please share the vacancy status and confirm whether shortlisting of candidates for interview completed.
- (3) The Appellant has submitted in the instant appeal that the response provided by the Respondent is incomplete as follows:
 - a) With reference to ICSI career opportunities advertisement dated 31st January 2024 for the post of Information Security Officer and IT Security Manager. The request was made to share the current vacancy status and to confirm whether shortlisting of candidates for interview completed. However, from the response, answers are still unanswered. These questions don't have any impact on the ongoing recruitment process because no personal information is asked. Only generic information is requested. Please direct the concerned officer to provide the requested information at

the earliest.

(4) The reply of the Respondent against the instant appeal is as under: -

“Since the RTI application pertains to the Directorate of Human Resources of the ICSI, therefore, the CPIO has asked for written submission from the concerned Directorate for the same. Their submission is mentioned below:

“Shortlisted candidates have been informed for the interview scheduled.”

Therefore, the appeal deserves to be dismissed.”

(5) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.

This office concurs with the submissions of the Respondent in his reply to the instant appeal.

The appeal is accordingly disposed of.
