(3) The Appellant has submitted in the instant appeal as follows:

"By applying through this link (as mentioned in the reply) we get only photo copy of answer sheet and only marks are shown on other page and not the checked one where we get to know where and why institute have not given marks. So I want checked certified copies"

(4) The reply of the Respondent against the instant appeal is as under: -

"It is submitted that procedure to access the requisite information as sought by the Applicant (Appellant hereinafter) in RTI Application ICSOI/R/E/24/09370

dated 26.08.2024 was provided to the Applicant on 02.09.2024 and subsequently the sought information was received and accessed by the Appellant (screen shot attached).

However, in the instant Appeal the Appellant has asked questions which were not a part of his original RTI Application i.e. system of providing marks against the questions attempted.

Further, this is to inform that the marks allotted against each question are clearly given on the answer book and no deviation has been found.

The contents as above made in the RTI reply stands as it is and are candid.

Therefore, the appeal deserves to be dismissed in-limine.."

(5) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.

This office concurs with the submissions of the Respondent.

The appeal is accordingly disposed of.
