- (1) The Appellant has filed first Appeal- No. ICSOI/A/E/24/00087 on 11.09.2024 under Section 19(1) of the Right to Information Act, 2005 in connection with the Response vide letter dated 07.09.2024 against the Central Public Information Officer (EXAM) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- (2) The Appellant vide his RTI Application No. ICSOI/R/E/24/11066 dated 28.08.2024 has requested for following information:

(3) The Appellant has submitted in the instant appeal as follows:

"I Applied for Scanned certified copies of CS Executive held in June 2024 under Right to Information Act, 2005.

Below is the response I got by the authorities.

As per the response I followed the steps given by the authorities.

But when I check institutes website to get the certified copies from the Institute Of Company Secretaries Of India.

I got to know that to get the certified copies from the institute you need a laptop or a desktop to access the files which is not available near me.

This is what written on the websites: -

The applicant student should open the link in computer/laptop only. The link for accessing copy of answer books shall not be opened on Mobile Phones.

That's the reason I'm applying from Right to Information Act 2005 to get my certified copies.

I hope my queries will be solved and my certified copies will be given through RTI by the relevant Authorities."

(4) The reply of the Respondent against the instant appeal is as under: -

"It is submitted that procedure to access the requisite information as sought by the Applicant (Appellant hereinafter) in RTI Application ICSOI/R/E/24/11066 dated 28.08.2024 was provided to the Applicant on 07.09.2024 and subsequently the sought information was received and accessed by the Appellant on 25.09.2024 (screen shot attached).

However, in the instant Appeal the Appellant has enquired about the requirement of laptop for accessing the Answer Books, which was not part of his original RTI Application is groundless as the requirements have already been specified to the public at large as it is available in public domain at the website of the Institute.

Further, since the Appellant has already viewed his Answer Books, no further information is required to be provided.

The contents as above made in the RTI reply stands as it is and are candid.

Therefore, the appeal deserves to be dismissed in-limine."

(5) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.

This office concurs with the submissions of the Respondent.

The appeal is accordingly disposed of.
