ORDER

- (1) The Appellant has filed first Appeal- No. ICSOI/A/E/24/00088 on 12.09.2024 under Section 19(1) of the Right to Information Act, 2005 in connection with the Response vide letter dated 12.09.2024 against the Central Public Information Officer (EXAM) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- (2) The Appellant vide his RTI Application No. ICSOI/R/E/24/12221 dated 10.09.2024 has requested for following information:

“Kindly provide certified copies of CS Professional June 24 of V. Narayanan, Reg no 320000223/08/2012, Roll 614655 for following papers:

Corporate Funding and Listing
Multi-Disciplinary Case Studies”
- (3) The Appellant has submitted in the instant appeal as follows:

“I had applied for certified copies of CS Professional held in June 24 Roll no 614655 of Corporate Funding and Multi-Disciplinary case studies, my request has been disposed of without providing the certified copies, kindly do the needful.”
- (4) The reply of the Respondent against the instant appeal is as under: -

“It is submitted that the requisite information as sought by the Applicant (Appellant hereinafter) in his RTI Application ICSOI/R/E/24/12221 dated 10.09.2024, was provided to

the Appellant vide letter dated 12.09.2024 in which the Appellant was informed about weblink and the procedure to fetch the sought information (copy of letter enclosed). An announcement in this regard was also published on the website of the Institute (copy of announcement attached).

Further, it is to inform that Appellant has already accessed the required information through the above mentioned portal on 24.09.2024 (copy of screen shot attached).

Furthermore, in the instant Appeal the Appellant's contention about non receipt of Certified copies is groundless and stands invalid.

The contents as above made in the RTI reply stands as it is and are candid.

Therefore, the appeal deserves to be dismissed in-limine."

- (5) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.

This office concurs with the submissions of the Respondent.

The appeal is accordingly disposed of.
