ORDER

- (1) The Appellant has filed first Appeal- No. ICSOI/A/E/24/00098 on 08.10.2024 under Section 19(1) of the Right to Information Act, 2005 in connection with the Response vide letter dated 20.09.2024 against the Central Public Information Officer (EXAM) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- (2) The Appellant vide his RTI Application No. ICSOI/R/E/24/12369 dated 16.09.2024 has requested the following information:
 - "1. To provide Evaluated copy of Answer Book(s) of all papers of Executive Module 1 Exam pertaining to MR. YOGESH KRISHNA SHUKLA, Roll No. 73366, Registration No. 241173513/11/2023.
 - 2. No solution given regarding not being able to see the evaluated answer books online even after my emails dated 10th September 2024 and 12th September 2024"
- (3) The Appellant has submitted in the instant appeal as follows:

"NO CORRECT DOCUMENTS FOR PROVIDED"

(4) The reply of the Respondent against the instant appeal is as under: -

"It is submitted that procedure to obtain the requisite information as sought by the Applicant (Appellant hereinafter) in his RTI Application ICSOI/R/E/24/12369 dated 16.09.2024, was

provided to the Appellant on 20.09.2024 in which the Appellant was informed about weblink and the procedure to fetch the sought information (copy of letter enclosed).

An announcement in this regard was also published on the website of the Institute www.icsi.edu – Examination – Result – Announcement (Supply of copy of Answer Book(s) to the students of CS Examination – June, 2024). (copy of announcement attached).

Subsequently, the Appellant applied for the Answer Books which were provided to her and remained available for viewing from 10.09.2024 to 09.10.2024. However, the Appellant did not view the Certified copies during this window (copy of screenshot attached)..

Further, the Appellant raised concerns about non-availability of Answer Book and sought replies against below mentioned queries.

2	अपील के कारण व आधार — (2) सामान्य व स्वामाविक नियम है कि जिस भाषा में आवेदन प्रस्तुत हो उसका उत्तर/पत्र व्यवहार उसी भाषा में दिया जाना चाहिये विशेष कर तब जबिक भारत सरकार हिन्दी में लिखने/पढने को बढावा देती है और शासनादेश भी जारी करती है।	Following facts were considered for deciding upon the language of Reply- 1.The student Ms. Anukriti Krishna Shukla opted "English" as medium of writing the Examination (Annexure-3). 2. The student used "English" throughout during her correspondence with the Various departments of ICSI (Annexure – 4 and Annexure – 5).
		 4. The CS Course is designed in "English medium" and students are expected to have at least a working knowledge of English Language to successfully complete the Course. 5. The RTI Portal maintained by Ministry of Personnel, Public Grievances and Pensions is designed in such a way that it

		facilitates replying RTI Applications in "English medium".
		5. The student herself never complained about not being able to understand "English". In fact, her father has suggested to make replies in "Hindi medium".
		Based on points mentioned above CPIO has no reason to believe that a reply in "Hindi medium" is essential.
		However, if the student is still unable to understand the reply made to her in "English Language" it shall be provided to her once again in "Hindi medium" upon receiving a request from her".

4	बिन्दु न0 4— जनसूचनाधिकारी महोदय द्वारा प्रेषित सूचना बिना हस्ताक्षर व आफिस सील के है तथा उपरोक्त सूचना सिर्फ दर्ज है ? जबिक उसका दस्तावेजी रेकार्ड नहीं है एैसे में सूचना किस अधिकारी द्वारा जारी किया गया है वो स्पष्ट नहीं है, अतएव सूचना अप्रमाणित व अपूर्ण है तथा अपील किये जाने योग्य है।	The reply given to the Applicant is through a system generated letter from the RTI Portal maintained by Govt. of India and is as per norms and Regulations, and thus cannot be treated as invalid (Annexure – 6).

(5) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.

This office concurs with the submissions of the Respondent.

The appeal is accordingly disposed of.
