ORDER

- (3) The Appellant has informed in the instant appeal that "Refused access to Information Requested".
- (4) The reply of the Respondent against the instant appeal is as under: -

"It is submitted that we have provided the requisite information as sought by the Applicant (Appellant hereinafter) in his RTI Application ICSOI/R/E/23/05500 dated 01.03.2023, at the email id of the Appellant registered with the Institute of Company Secretaries of India vide email dated 23.03.2023 and once again on 11.04.2023 in which a web-link, Username and Password have been provided to the Appellant to access the information sought.

Further, the date of accessing the scanned copies has also been extended till 20.04.2023.

The contents as above made in the RTI reply stands as it is and are candid".

- (5) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
- (6) This Office concurs with the submission of the Respondent. Respondent has provided the response to Appellant vide email dated 23.03.2023 & once again on 11.04.2023 & also date extended till 20.04.2023 to access the scanned copies/ information sought. Appellant is requested to check his email id.

The appeal is accordingly disposed of.
