**ORDER**

- (1) The Appellant has filed first Appeal- No. ICSOI/A/E/23/00110 on 25.03.2023 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. No. ICSOI/R/E/23/04678 dated 22.03.2023 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- (2) The Appellant vide his application dated 28.02.2023 has requested to provide the certified copy of answer sheet for CS Executive Programme examination, Session: December ,2022 for the subject: 01 SECURITIES LAWS AND CAPITAL MARKETS (426)
- (3) The Appellant has informed in the instant appeals that "Details not provided".
- (4) The reply of the Respondent against the instant appeal is as under: -

"It is submitted that we have provided the requisite information as sought by the Applicant (Appellant hereinafter) in his RTI Application ICSOI/R/E/23/04678 dated 28.02.2023, at the email id of the Appellant registered with the Institute of Company Secretaries of India vide email dated 22.03.2023 and once again on 13.04.2023 in which a web-link, Username and Password have been provided to the Appellant to access the information sought."

Further, the Appellant acknowledged the receipt of the same vide email dated 13.04.2023.

The contents as above made in the RTI reply stands as it is and are candid".

- (5) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
