## ORDER

- (1) The Appellant has filed first Appeal- No. ICSOI/A/E/23/00113 on 25.03.2023 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. No. ICSOI/R/E/23/04378 dated 21.03.2023 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- (2) The Appellant vide his application dated 28.02.2023 has requested to provide the certified copies answer sheets for CS Professional Programme examination, Session: December ,2022 for the subjects: 01 Governance, Risk Management, Compliance and Éthics, 02 Advance Tax Law, 03 Multidisciplinary Case Studies, 04 Drafting, Pleading and Appearances, 05 Insolveny Law and Practice.
- (3) The Appellant has informed in the instant appeals that "Provided Incomplete, Misleading or False Information".
- (4) The reply of the Respondent against the instant appeal is as under: -

"It is submitted that we have provided the requisite information as sought by the Applicant (Appellant hereinafter) in his RTI Application ICSOI/R/E/23/04378 dated 28.02.2023, at the email id of the Appellant registered with the Institute of Company Secretaries of India vide email dated 21.03.2023 and once again on 17.04.2023 in which a web-link, Username and Password have been provided to the Appellant to access the information sought.

Further, the date of accessing the scanned copies has also been extended till 25.04.2023.

The contents as above made in the RTI reply stands as it is and are candid".

- (5) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.
- (6) This Office concurs with the submission of the Respondent. Response provided by CPIO EXAM to the Appellant to access the information sought vide email dated 21.03.2023 and once again on 17.04.2023 & also date extended till 25.04.2023 for accessing the scanned copies. Appellant is requested to check his registered email ID.

The appeal is accordingly disposed of.
