"Please provide the attendance details / records of Mr. K C Kaushik, Employee of ICSI for the below dates.

On 1st April, 2017

On 18th April, 2017

On 11th May, 2017

On 20th June, 2017

On 6th July, 2017

On 25th July, 2017

On 15th September, 2017

On 7th October, 2017

On 7th November, 2017

Please confirm whether Mr. K C Kaushik was worked in the office on the above days or on Leave."

(3) The Appellant has submitted in his instant appeal with regards to the reply provided by the Respondent to the RTI queries as under:

"Information sought has high level public interest. How can it be denied? An employee during office hours not in office so I have right to know whether the employee was on leave or without applying the leave left the office for personal works. Employee salary is being paid from public money only. So information has to be provided."

(4) The reply of the Respondent against the instant appeal is as under: -

"Since the RTI application pertains to Directorate of HR of the ICSI, therefore, the CPIO has asked for written submission from concerned Directorate for the same. Their submission is mentioned below:

"We reiterate our earlier reply."

Therefore, the contents made in the RTI Reply stands as it is and the appeal deserves to be dismissed."

(5) This Office has carefully considered the application, the response, the appeal and the records made available and finds that the matter can be decided based on the material available on record.

This office concurs with the submissions of the Respondent in his reply to the instant appeal.

The appeal is accordingly disposed of.
