ORDER

- (1) The Appellant has filed first Appeal- No. ICSOI/A/E/23/00115 on 25.03.2023 under Section 19(1) of the Right to Information Act, 2005 in connection with Response Ref. No. ICSOI/R/E/23/01246 dated 10.03.2023 against the Central Public Information Officer (CPIO) (hereinafter referred to as Respondent) of the Institute of Company Secretaries of India.
- (2) The Appellant vide her application dated 25.02.2023 has requested to seek the information for the Subjects: 01: JIGL 02: COMPANY LAW 03: SBEC 04: tax 05: CMA 06: Slaw 07: EBCL 08: FSM.
- (3) The Appellant has informed in the instant appeal that "No Response Within the Time Limit."
- (4) The reply of the Respondent against the instant appeal is as under: -

" It is submitted that we have provided the requisite information as sought by the Applicant (Appellant hereinafter) in her RTI Application ICSOI/R/E/23/01246 dated 25.02.2023, at the email id of the Appellant registered with the Institute of Company Secretaries of India vide email dated 10.03.2023 and once again on 20.04.2023 in which a web-link, Username and Password have been provided to the Appellant to access the information sought.

- (6) This Office concurs with the submission of the Respondent. Appellant is requested to check her email id.
