- (4) The reply of the Respondent against the instant appeal is as under: -

"It is submitted that we have provided the requisite information as sought by the Applicant (Appellant hereinafter) in his RTI Application ICSOI/R/E/23/00452 dated 25.02.2023, at the email id of the Appellant registered with the Institute of Company Secretaries of India vide email dated 07.03.2023 and once again on 24.03.2023 in which a web-link, Username and Password have been provided to the Appellant to access the information sought. The contents as above made in the RTI reply stands as it is and are candid".
